



FITTING INSTRUCTIONS

- Bolt the adaptor plates (**Items 2 & 3**) and spacers (**Items 4 & 5**) through the 4x holes in the OE rack using the M8 button head bolts (**Items 6 & 7**) in the orientation shown in the assembly diagram.
- Place the rack plate (**Item 1**) on top of the brackets and secure to the brackets with the M8 countersunk bolts (**Item 8**).

PLEASE NOTE:

- To fit a SHAD Terra topbox to the rack you will need R&G kit ARSHAD0001
- GIVI Trekker Outback topbox requires SW-Motech part no. GPT.00.152.35400/B
- SW-Motech TRAX ION/ADV/EVO requires SW-Motech part no. GPT.00.152.35100/B

R&G Adventure Rack load capacity 10KG. Always check your motorcycles manufacturers guidelines before carrying any load.


