





FITTING INSTRUCTIONS

- Remove the 3 OEM bolts in the locations circled in the picture above.
- Thread the 45mm bolt (Item 6) through the 5mm spacer (Item 3) washer (Item 9) and slider (Item 1) in the location circled in red in the fitting picture.
- Repeat this process with the 50mm bolt (Item 7), the 10mm Spacer (Item 4) and washer (Item 9) in the location circled in yellow.
- Repeat this process with the 60mm bolt (Item 8), the 23mm Spacer (Item 5) and remaining washer (Item 9) in the location circled in blue.
- Offer the assembly up to the bike as shown in the fitting picture above and tighten the bolts fully.




NOTICE DE MONTAGE

- Retirez les 3 boulons d'origine aux emplacements entourés sur l'image ci-dessus.
- Enfilez le boulon de 45 mm (article 6) à travers l'entretoise de 5 mm (article 3), la rondelle (article 9) et la protection (article 1) à l'emplacement entouré en rouge sur l'image de montage.
- Répétez ce processus avec le boulon de 50 mm (article 7), l'entretoise de 10 mm (article 4) et la rondelle (article 9) à l'emplacement entouré en jaune.
- Répétez ce processus avec le boulon de 60 mm (article 8), l'entretoise de 23 mm (article 5) et la rondelle restante (article 9) à l'emplacement entouré en bleu.
- Présentez l'assemblage sur la moto comme indiqué sur l'image de montage ci-dessus et serrez complètement les boulons.
