



FITTING INSTRUCTIONS FOR EH0044BK EXHAUST HANGER **YAMAHA FZ8 2010**

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

- Remove the original rear footpegs/exhaust hanger.
- Place the two M8 button head bolts from kit through the two top holes in the R&G hanger.
- Offer up to bike as shown above and engage threads (do not tighten yet).
- Place the M10 button head bolt from kit through the exhaust mounting hole (lower hole in bracket).
- Place the rubber gasket over exposed end of bolt (so it sits between hanger and exhaust mounting bracket).
- Engage the thread into the captive exhaust mounting nut.
- Tighten all bolts evenly.
- Please ensure when the motorcycle is being used that no parts are in such a position that they may collide/damage other bike parts (this is particularly important if using after-market cans or exhaust systems).

Please note that it is your responsibility to ensure that no part of the exhaust hanger or exhaust assembly fouls or comes into contact with other parts of the machine. Do not ride the motorcycle until this aspect has been verified and you have compressed the rear suspension (if appropriate to the design of the motorcycle) to test this thoroughly.

Notez s'il vous plaît que la façon dont le kit est emballé ne représente pas nécessairement la façon de montage sur la moto.

- Enlever le support d'échappement / repose pied arrière d'origine.
- Placer deux vis M8 (fournies dans le kit) à travers les deux trous (les plus en haut) sur le nouveau support R&G.
- Placer le tout sur la moto et engager à la main les vis (ne pas serrer pour le moment).
- Placer la vis M10 (fournie dans le kit) à travers le trou sur le nouveau support R&G. (trou de fixation positionné en bas du support de pot).
- Placer le joint en caoutchouc sur le filetage de la vis précédemment installée. (cette pièce sera donc placée entre le support R&G et la patte de fixation du silencieux).
- Engager ensuite la vis M10 dans le filetage de l'écrou situé sur le silencieux.
- Serrer les 3 vis.
- Assurez qu'aucune pièce ne puisse être en contact/collision avec les autres pièces de la moto. (Particulièrement important lorsque le silencieux et autres accessoires sont des pièces adaptables).

Notez s'il vous plaît que c'est votre responsabilité d'assurer qu'aucune partie du support d'échappement ou de l'échappement ne puisse entrer en contact avec d'autres parties de la machine. Ne roulez pas avec le véhicule avant d'avoir vérifié le bon montage de la pièce (compresser la suspension arrière pour vérifier la qualité du montage).



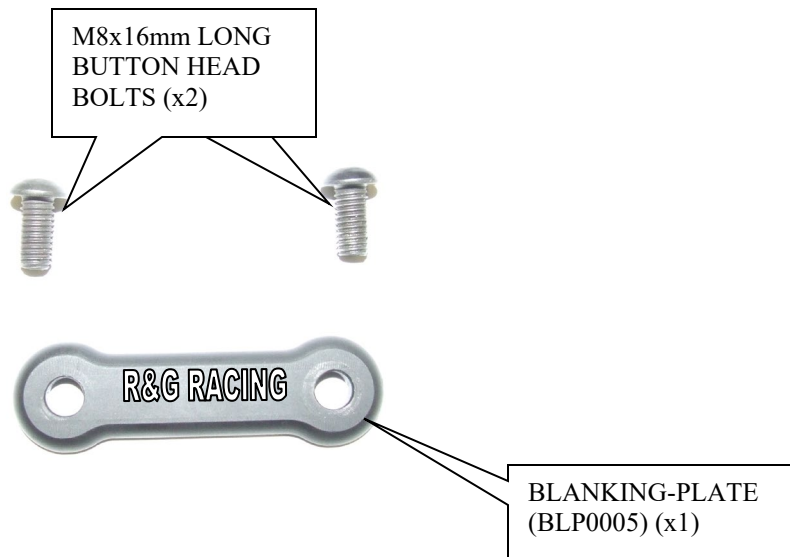

TOOLS REQUIRED

- Set of metric Allen keys to include 5 and 6mm A/F sizes.

FITTING INSTRUCTIONS

- Using 6mm allen key remove the two bolts and remove rear footrest.
- Fit two of the button headed bolts through the blanking plate.
- Offer assembly up to bike and engage both bolts
- Tighten evenly using 5mm Allen key.
