


# FITTING INSTRUCTIONS FOR EH0079BK EXHAUST HANGER KTM DUKE 125 2017-



### **TOOLS REQUIRED**

- Set of metric Allen keys to include 5 & 6mm A/F sizes.
  - Socket set to include 14mm socket & wrench.

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away*!

- Remove the two bolts arrowed in Picture 1 using a 5mm Allen key and remove metal bracket.
- Remove the two bolts arrowed in Picture 2 using a 6mm Allen key.
- Remove the bolt arrowed in Picture 3 using a 14mm Socket and a wrench. Please note to keep the OEM exhaust hanger supported during this process. Remove the OEM Exhaust hanger.
- Locate R&G exhaust hanger in position as original. Secure the two top mounts of the exhaust hanger to the subframe using two M8 bolts and washers provided in the kit. Do not fully tighten the bolts at this stage.
- Locate the spacer (Item 4) behind the lower mount of the exhaust bracket so that the spacer sits between the exhaust bracket and the exhaust can's clamp. Secure using OEM bolt removed at earlier stage.
- Tighten all three bolts.
- Please ensure when the motorcycle is being used that no parts are in such a position that they may collide/damage other bike parts (this is particularly important if using after-market cans or exhaust systems).

Please note that it is your responsibility to ensure that no part of the exhaust hanger or exhaust assembly fouls or comes into contact with other parts of the machine. Do not ride the motorcycle until this aspect has been verified and you have compressed the rear suspension (if appropriate to the design of the motorcycle) to test this thoroughly.



- Enlever les 2 boulons indiqués sur la photo 1 en utilisant une clé Allen 5mm puis enlever le support en metal.
- Enlever les 2 boulons indiqués sur la photo 2 en utilisant une clé Allen 6mm.
- Enlever le boulon indiqué sur la photo 3 en utilisant une clé à cliquet + douille 14mm. Notez qu'il faut support le support pot d'échappement d'origine pendant l'opération. Enlever le support pot d'échappement d'origine.
- Placer le support pot d'échappement R&G en position comme à l'origine. Fixer les 2 supports supérieurs du support pot d'échappement au sous-cadre en utilisant les 2 boulons M8 et rondelles fournis dans le kit. Ne pas serrer complètement les boulons à ce stade.
- Placer l'entretoise (Article 4) derrière le support inférieur du support pot d'échappement de façon à ce que l'entretoise se place entre le support pot d'échappement et la pince d'échappement. Fixer avec le boulon d'origine enlevé plus tôt..
- Serrer les 3 boulons.
- Vérifier qu'aucune partie de la moto ne puisse potentiellement heurter une autre partie de la moto lors de son utilisation (cela est particulièrement important si vous utilisez un pot d'échappement qui n'est pas d'origine).

#### **TOOLS REQUIRED**

• 5 and 6mm A/F metric Allen key.

#### FITTING INSTRUCTIONS

- Remove rear footrest on the left side of the bike.
- Fit the two counter-sunk head bolts through the holes in the blanking plate.
- Offer assembly up to bike and engage both bolts as shown in top picture.
- Tighten evenly using 5mm Allen key.
