

## **LEGEND**

ITEM 1 = BLANKING PLATES (BLP0071) (x2).

ITEM 2 = M8 WASHERS (x4).

ITEM  $3 = M8 \times 1.25 \times 25 \text{mm}$  LONG CAP HEAD BOLTS (x4).

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!* 

# TOOLS REQUIRED

• 5 & 6mm metric Allen key.

## **Fitting Instructions**

- Remove the two bolts that secure the OEM pillion footrests in place on both sides of the bike. The footrest hangers should now come away from the bike.
- Fit two bolts and washers through either blanking plate and offer up to the bike, before tightening.
- Repeat the above process to fit the blanking plate to the other side of the bike, ensuring the logos are facing outwards.
- Ensure all bolts are tightened evenly.



## NOTICE DE MONTAGE

- Enlever les 2 boulons qui fixent les repose pieds d'origine en place des 2 côtés de la moto. Les supports de repose pieds doivent maintenant pouvoir s'enlever de la moto.
- Insérer les 2 boulons et rondelles dans la plaque d'obturation et montez la sur la moto, avant de serrer
- Répéter l'opération ci-dessus pour monter la plaque d'obturation de l'autre côté de la moto, en veillant à ce que les logos soient orientés vers l'extérieur.
- Veiller à ce que tous les boulons soient correctement serrés et de façon identique.
