



## **FITTING INSTRUCTIONS FOR LPK0003BK LICENCE PLATE EXTENSION (UNIVERSAL)**

- Fit the extensions to the tail tidy using two of the button head bolts (do not tighten yet).
- Fit your licence plate to the extensions using the two remaining button head bolts (you have three holes to choose from to suit the required position of the licence plate (do not tighten yet).
- When you are satisfied with the position of your licence plate tighten all of the bolts.
