



## **FITTING INSTRUCTIONS FOR LP0063BK LICENCE PLATE BRACKET HONDA CBR1000RR FIREBLADE 2008**



**Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike**

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

### **PLEASE NOTE YOU WILL REQUIRE WURTH SUPER GLUE AND ACTIVATOR AND A TUBE OF SILICON SEALANT**

- Remove OEM tail unit as described in Honda alarm manual.
- Lay rear light cables, indicator cables and alarm cables along central channel.
- Using Wurth super glue and Wurth super glue activator carefully glue plate in place as shown above left (glue using outer strengthening webs only). Please follow the adhesive instructions carefully.
- It is also recommended that a fillet of Silicon is run down the outside edges of panel as an extra security measure.
- Fit rubber grommets and spacers (from OEM mounting kit) to alarm housing/cover as described in alarm manual.
- Using washers (from OEM mounting kit) and new screws supplied in kit secure cover in place as described in alarm manual.

#### **R&G RACING RETURNS POLICY (NON-FAULTY GOODS)**

Returns must be pre-authorized (if not pre-authorized the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
